From the Chairperson - Waihaere Mason

Tēnā koutou te whānau o Ngāti Kuia.

Since our last communication there has been some movement in Settlement issues, general planning, and Marae matters.

It is with some relief that our Ngāti Kuia Bill before Parliament received its final reading and approval in April 2014 and now becomes an Act. This means that come August we can utilise our total Settlement with some immediate benefits both culturally and economically. We are pleased that our roopu that represented us at the third reading came from whanau who have contributed, in no mean way, to the Ngāti Kuia cause. Of note, were three rangatahi who, in the beginning, were carried from hui to hui and who now sing our waiata and carry out ringawera mahi. Such is loyalty.

As noted, in the General Managers comments, we have finally completed our Strategic Plan which also refers to our Statement of Investment Policy (SIPO). As promised, this will be presented at our Annual General Meeting later in the year. It is based around those ideas gleaned from our Road Shows and many planning sessions. It follows clear pathways along cultural, social, and economic areas of development with achievable outcomes, over sensible timeframes. In the initial stages of economic development there were areas thought inappropriate for investment. Further consideration needs to be given to this important area.

From a cultural perspective we hope that all have enjoyed "Riding the Wai" a publication telling of one of our treasured stories. Now, what do you think of this next one!!.

The Wharekai saga is all but over. In the near future the Land Trustees will decide timeframes to the building of this important facility once building consent is finally granted. As all will expect, we will lay down the mauri in the ways of our tupuna, when that time comes.

Interim Manager Report - David Johnston

Thank you for the opportunity to be your Transitional Manager.

There has been a lot of work behind the scenes in terms of pre and post settlement mahi. We are in a very good position in terms of our progress and I would like to acknowledge the work of staff, mandate representatives and trustees.

Every month I provide a dashboard to the board with traffic light coding based on how we are going. I am pleased that we have lots of green lights and are also able to focus on any areas that need attention. Some highlights include:

Te Tangata:

- ✓ Our Strategic and Annual Plans have been finalised
- ✓ Completed review of our Grants/Scholarships and increased the putea available effective 1 April 2014
- ✓ A post settlement structure review is currently in progress with recommendations due to the board July 2014

Te Taiao:

- ✓ Participation in Taonga Tūturu hearings
- ✓ Cultural Property Management Plans formalised
- ✓ Successful Titirangi wananga in May

Ngāti Kuiatanga:

- ✓ Second publication of "A Titi Tale"
- ✓ Te Reo night classes held at Rūnanga offices via NMIT
- ✓ Developing relationship with Te Kura Kaupapa Maori o Tuia Te Matangi

Te Putea:

- ✓ Our company directors are fully implementing the investment strategy now we have settled.
- ✓ Due diligence is being carried out on school properties. The lease agreements and terms are very favourable to Ngāti Kuia.

Thank you for your patience with the wharekai development. Changes to Resource Management and particularly fire permits have led to the delays. With every cloud there is a silver lining. We appear very close with 1 item to be resolved. The delays have meant we can re-apply to the lotteries for funding grants to help with the build.

Waihaere Mason - Member of the New Zealand Order of Merit



In this year's Queen's Birthday Honour's, our Chairman, Waihaere Mason was made a Member of the New Zealand Order of Merit in recognition of his services to education and Māori.

Waihaere has been a Trustee and Chairperson of Ngāti Kuia since 1999. He was the Chairperson during the Waitangi Tribunal claims process and settlement negotiations for Ngāti Kuia, as well as the subsequent settlement in aquaculture.

After 45 years dedicated to education around New Zealand, Waihaere retired as principal of Nelson Intermediate School in 2009.

He recently told a local Nelson newspaper that "Whether it is by charitable acts or personal sacrifice is not important. What is important is that those who are able have a moral responsibility to do what we can to support others through this challenging world we live in".
